#### **Insurance Reimbursement for Diabetes Prevention Program**

### Medicare Coverage in 2018 CMS recently released final guidance on the Medicare Diabetes Prevention Program

(MDPP) benefit. H<mark>ere are some key points:</mark>

- Only CDC Recognized Programs will be able to submit for reimbursement
- Programs must register to become a supplier (in 2017) of MDPP
- Proposes benefits for maintenance sessions (for qualifying members) after the post-core phase
- Must have BMI ≥25 (CDC only requires ≥24)
- Once per lifetime benefit
- Must have clinical diagnosis of prediabetes or gestational with copy of a qualifying blood test
- Lifestyle Coaches must obtain a NPI and suppliers must submit a roster of all coaches with required information
