October 2020: Munson Medical Center Pediatrics provided 100 hours of inpatient care.

October 2021: They provided 900 hours – more patients, staying longer than they did a year ago.



Pandemic Response Plan Stages



Level Green

No pandemic activity, but moderate to high potential exists.

Level Blue

Pandemic has begun; cases identified in the United States. No cases in Michigan.

Level Yellow

Sporadic cases in Michigan, but few in number locally.

Level Orange

Widespread community cases locally.

Level Red

Overwhelming number of local cases beyond capacity of the healthcare system.



What Does Pandemic Level Red Mean?

- This is the first time in MHC history.
- In many ways we have already been operating in "Red", and we still have the ability to care for patients.
- What changes?
 - COVID-19 care prioritized.
 - Scaling back of services. (example: Sleep Disorders, some elective procedures)
 - Hours of operation at clinics and labs may be adjusted.
- What stays the same?
 - No changes to MHC's current visitor policy

COVID-19 Vaccines for Children Ages 5-11

As announced last week, kids ages 5-11 are now eligible for Pfizer's COVID-19 vaccine.

Available appointments for pediatric COVID-19 vaccines have filled up quickly at many of the available locations and you may be placed on a waiting list until a spot opens up. (There is plenty of availability for adult vaccines.)

Call your Pediatrician/Primary Care Provider to see if they are offering the vaccine.








Vaccination rates overall*: 68.6% initiated COVID Vaccine Coverage by Age Group

CDC APPROVES PFIZER VACCINE FOR AGES 5 - 11

- On Tuesday, November 2, 2021, the Centers for Disease Control and Prevention (CDC) recommended the use of the Pfizer COVID-19 vaccine for children ages 5 -11 years as a 2-dose series taken 3 weeks apart.
- Appointments for the week of November 8 12 through the Grand Traverse County Health Department (GTCHD) are full. Appointments for the week of November 15 -19 will be made available on Wednesday, November, 10, 2021 at 10 a.m. The link can be found at www.gtcountymi.gov/2394
- Recognizing the nuances that come along with immunizations in a younger population, all pediatric appointments made will be conducted at the main health department building located at 2600 LaFranier Rd., Traverse City, MI 49686 - not the Cherryland Clinic.





Cherryland Vaccination Clinic Schedule for week of 11/08 - 11/12:

Tuesday 11/9 and Wednesday 11/11 from 9 a.m. - 4 p.m.

- Pfizer, Moderna, and J&J offered.
- Clinic schedule will vary based on resources and demand, currently partnering with HONU to help accommodate booster demand.

- Appointments are required, no walk-ins at this time.

- Clinics for 5-11 year-olds open for appointments
 - Positive response to clinics from parents/guardians
 - Appointments readily available
 - Clinics separate for younger clients: smaller and geared toward young children
- K-12 cases and Mask Order
 - K-12 School Mask Order for HDNW and BLDHD still in place
 - Slight modifications made for clearer definition of appropriate masks, exemption to residential schools if following approved mitigation plan, and exemption for students and officials actively engaged in sport/performing arts in practice or competition/performance if participating in testing program described by Health Department Athletics and Performing Arts Guidance.
- What we want our jurisdiction to know
 - Parents/guardians are making the right choice to have their young child vaccinated to protect themselves, their family and the community-at-large
 - Research and scientists back that vaccine is safe and effective




Districts without mask requirements are experiencing higher case rates

- 5–18-year-old school population case rates are higher and rose faster in districts without mask requirements
- Districts with complete or partial mask requirements have seen lower case rates with slower increases
- Note districts may change categories as mask rules change
- Note that districts with mask rules may also have other prevention measures (vaccination, testing, etc.) that reduce transmission levels



Masks required = mask required for all grades; Partial mask req. = tilered, some grades, based on vax status, staffonly; Few/no req. = no req. or buse sonly. Blue line & shaded region is a linear trend fit. Data Sources: MDSS/MDHHS case data as of 10/29/21 geocoded to school district, EOG School District Mask Policy Tracker data. Note: Cases are among all 5-18 year olds, population is the school-enroll ed population.






Back-to-school saw case rate increases for all ages. Increases were highest for counties without school masking.

- All mask levels and age groups had similar case rates prior to the back-to-school period
- During back to school, all counties saw some increase in case rates, with higher increases for school aged populations
- However, increases were larger for counties with fewer mask requirements
- In counties without school mask requirements, case rates more than tripled after back-toschool for school-aged individuals, and ~doubled for non-school-aged individuals

PUBLIC HEALTH

Cases from MDSS were examined at the county level (so that non-school age population counts were available) using a district mask risk level from the back to school period, a veraged to the county level. Mask levels from EOG School District Mask Policy Tracker.







District Health Department #10 COVID-19 Case Trends



- Cases increasing (13.7%): October 23- October 29= 812 cases; October 30 –
 November 5 = 923 cases
- Daily cases per million **decreasing**: October 21= **408.6**; October 28= **382.1**
- Percent positivity steady: October 21= 14.98%; October 28= 14.94%

District Health Department #10 COVID-19 Vaccination Trends



- 55.5% of DHD#10 residents have initiated vaccination
- 51.6% of DHD#10 residents have completed vaccination series
- Map shows vaccination rates among 16+ age group by zip code
 - Darker pink = lower vaccination rate
 - Darker green = higher vaccination rate

*Data as of 11/5/2021 **Eligible population now includes those 5 years and older, so percentage initiated/completed has decreased due to larger denominator


